

#### I. OPENING BUSINESS

9:00 a.m.

- Call to Order (John Aho, Chairperson); Roll call: Commission members John Aho, Gary Carver, Laura Kelly, Richard Koehler, Daniel Mahalak, David Miller, Mark Roberts, Robert "Buzz" Scher, and Gayle White were present. Roger Hansen arrived late. Commissioner Gay Dunham was absent.
- Introductions-Guests: Rod Combellick of the State Division of Geological & Geophysical Surveys (DGGS), Joanne Bennett, Alaska Division of Insurance (ADI), and Sam Kito of the Alaska Department of Education and Early Development (ADEED) were present.
- The meeting agenda was approved with one addition: commissioner Roberts added the discussion of a potential nomination for the Western States Seismic Policy Council (WSSPC) award that is due in February, 2011.
- Review and Approval of Minutes for the November 12, 2010 meeting: The minutes were approved with amendments.

II. BRIEFINGS 9:05 a.m.

- Recent Seismic Activity of Interest-Hansen: There were 2,230 events in December.
  There were 469 events in the week from December 29<sup>th</sup> through January 2<sup>nd</sup>. There
  were several events in the magnitude 4 to 5 range in the Aleutians. There were some
  events near Pump Stations Four and Five as well as some near Huslia and an event
  near Nome.
- Health of the Alaska Seismic Networks-Hansen: The Alaska Earthquake Information center (AEIC) continues to see more events in the northern part of Alaska than ever before, due partly to improvements in the network. They received 19 new, modern instruments from the United States Geological Survey (USGS) for sites in Anchorage. They hope to begin replacing older instruments with the new ones in February. Commissioner Hansen spoke with Jamie Steidl of the University of California, Santa Barbara, who installed the downhole instrument in downtown Anchorage. Mr. Steidl believes that the problems with the instrument were caused by a bad cable. They are now working on getting the cable replaced. They will also replace the downhole sensor, if needed, and the bedrock site.
- ShakeMap Update-Hansen: Nothing to report at this time.
- Municipality of Anchorage Geotechnical Advisory Commission (MOA/GAC) Activity Update-Scher: Commissioner Scher is the current chair of the GAC. The GAC has had two meetings since the last ASHSC meeting in November. Staff from the Port of Anchorage Expansion Project gave them a presentation on geotechnical instrumentation for the project. The MOA/GAC found that seismic instrumentation has not been funded for the project at this time. This is a billion-plus dollar project and a major piece of infrastructure for the state, and the commission feels that it should include seismic instrumentation. They are preparing a proposal to recommend instrumentation that will be completed in the next month or so. The MOA/GAC also heard a presentation from the consultant that has drafted some land-use regulations

for a proposed downtown Anchorage seismic district. The regulations are now in the hands of the Municipality Planning Department.

### III. OLD BUSINESS

# Committee Reports

- Insurance-White: She submitted the updated white paper to Chairman Aho and Glenn Pomeroy in December. She has also completed her committee summary for the ASHSC annual report.

- Hazards Identification-Carver: The committee met via teleconference after the last ASHSC meeting. They discussed the progress of the committee's white paper and agreed that it should be written to be accessible by the general public. Commissioner Carver will post what they have so far on the Wikispaces site so that committee members can continue to work on the paper.
